ARTICLE II: Duration: This Agreement will be in full force and effect as of 22 May 2019 until the date of the Final of World Cup 2022 in Qatar.

ARTICLE III: Undertakings and Commitments of the Head Coach

1) The Head Coach unconditionally undertakes and commits to respect the Iranian laws and cultural matters in his capacity as the Head Coach of the IRFF and in any advertising or marketing event or promotion which may be construed as his own commercial or business interests or any particular article or enterprise in Iranian Territory for the duration of this Agreement. From this potential revenue, the Head Coach will deliver a share to the IRFF, from which the IRFF will use as it's own discretion but mainly to compensate the payment (all or part) of the tax for the salary of the Head Coach in Iran Territory, that as per contract is a responsibility of IRFF.

2) The Head Coach also accepts not to participate in any scheduled interviews and/or news conferences or make any public comments related to any affairs of IRFF, except the questions and answers about the present situation of the National Football A Team at the pitch.

3) Moreover, the Head Coach undertakes not to accept or undertake any employment/labor-kind responsibility or assignment with any other Federation or Football Club other than the IRFF for the duration of this Agreement.

4) The Head Coach consents himself to accept and follow the whole regulations of the package provided by the sponsors of the IRFF under the terms and conditions of the contracts signed by the IRFF and the sponsoring companies, when in IRFF duty. This Agreement excludes equipment related to boots, shoes-wear; the Head Coach will have the right to choose boot wear from another brand upon his sole discretion in order to provide best comfort, without the necessity of any consent by IRFF.

5) The Head Coach commits himself to provide a comprehensive plan regarding his duties on

coach and based on the President approval. For this IRFF directly will make all concerned and required arrangements with other clubs or through other related official channels.

14) All technical missions of the head coach must be made based on the written request of the head coach and official approval of IRFF.

15) The Head Coach is committed to attend the ceremonies, festivals, gatherings and the seminars approved by the IRFF. His participation cannot interfere in his work as head coach of the National A Team of Iran.

16) The head coach acknowledges that his activities in the context of this agreement have to be executed not only in Iran, but all over the world, for scouting missions, tournaments, games, observation, visiting facilities, visiting clubs and other Federations, participate in events agreed with IRFF.

ARTICLE IV: Undertaking and Commitments of the IRFF and Terms of Payments:

1) IRFF undertakes to pay Head Coach a yearly sum (hereinafter the "Basic Compensation") of EUR 2.350.0000 NET, from 02/06/2019 until 05/06/2022, which totals an amount of 7.875.00000 (seven million eight hundred and seventy five thousand Euros) NET for the entire duration of this Agreement.

The mentioned amounts are NET of taxation. Head Coach will be submitted to the Iranian taxation. The IRFF will directly pay the head coach taxes in Iran and pay NET salary to the head coach. The IRFF will provide the Iranian taxation certificate to the Head coach, as prove that all taxes have been paid correctly in Iran:
